2. Demo Clause:- After opening of Technical Bid each Bidder shall have to demo the product at our Municipality in their own cost to prove their product quality and to clear that the technical specification of the product . After satisfaction bidders will be eligible for Financial Bid.

3. Eligibility criteria for participation in tender:
 - (i) Bonafied, reliable, resourceful and experience contractors having sound financial status and having credential not less than 40% of the value of similar nature of work in a single contract during preceding 5 (five) years under Govt./ Semi Govt./ Statutory of local bodies. Credential means completion certificate of a single contract of a similar nature of work.
 - (ii) Having annual turnover of at least 100% of estimated cost or above in any one year of last five Financial years for individual group.
 - (iii) Tenderers should submit Solvency certificate of at least 50% of estimated cost only from their banker / bankers regarding financial capability. [Non Statutory Documents].
 - (iv) In case of Proprietorship and Partnership Firms and Company the Tax Audited Report to be furnished along with balance Sheet and Profit and loss account and all schedules forming the part Balance sheet and Profit and Loss Account in favour of application.

7. Validity of Bid A Bid submitted shall remain valid for a period of 180 calendar days from the date set for openings of Bids. Any extension of this validity period if required will be subject to concurrence of the Bidders.
8. Withdrawal of Bid A Bid once submitted shall not be withdrawn within the validity period. If Bidder / Bidders withdraw his / their Bid (s) within the validity period then earnest money as deposited by him / them will be forfeited.
9. Acceptance of Bid The Chairman, Santipur Municipality will accept the Bid. He / She does not bind himself / herself to accept otherwise the lowest Bid and reserves to himself / herself the right to reject any or all of the Bids received without assigning any reason thereof.
10. Intimation The successful Bidder will be notified in writing of the acceptance of his Bid. The Bidder then becomes the "Contractor" and he shall forthwith take steps to execute formal contract Agreement in appropriate municipal forms with the chairman Santipur Municipality and fulfill all his obligations as required by the contract.
11. Escalation of cost (A) There will be no escalation in cost for materials or labours and the contract price mentioned in the contract.
- (B) Rate should be quoted in figures as well as in wards rate should be inclusive all taxes, duties and cess etc. which will not be paid extra.
12. Name & Address of Engineer – in – Charge (EIC) of the work. SAE, Santipur Municipality, Santipur, Nadia.
13. Execution of work The Contractor is liable to execute the whole work as per direction of The Chairman, Santipur Municipality and SAE , Santipur Municipality, Santipur, Nadia.
14. Payment Payment will be made to the successful Bidder by the Chairman, Santipur Municipality.

15. Influence Any attempt to exercise under influence in the matter of acceptance of Bid is strictly prohibited and any Bidder who restores to this will render his Bid liable to rejection.

Following clauses are to be adhering to by the concerned Bidder during the process of Bidding.

16. In case office faces sudden closure owing to reason beyond the scope and control of the Chairman, any of last date / dates as schedule in SI No,6 may be extended up to / to next and following working day without issuing further and separate notice should the Chairman feel it to be necessary and exigent.
17. Persons having authenticated and having registered power of Attorney may be considered lawfully becoming to be acting on and for behalf of the Bidder.
18. Sufficient care has been taken to avoid variance in between the contents of the listed documents in the Bid documents. However, if there is any variance between the contents of different documents, the provision of documents appearing earlier in the list shall prevail over the same provided in the contents coming later.
19. Imposition of any duty / Tax / rule etc. owing to change / application in legislation / enactment shall be considered as a part of the contract and to be adhering to by the Bidder / Contractor strictly.
20. Bid acceptance authority is the Chairman, Santipur, Municipality.
21. In case of any dispute arising from any clauses of similar nature between Bid documents and municipal tender form, the decision of Superintending Engineer, East Circle, M.E. Directorate, will be final and binding.
22. All usual documents for taxes i.e. Security, I.T.,G.S.T . and Labour welfare cess etc. as applicable will be made from the bills from time to time.
23. No conditional / incomplete Bid shall be entertained.
24. In the event of e – Filing intending bidder may download the tender documents from the website [http:// wbtenders.gov.in](http://wbtenders.gov.in) directly by the help of Digital Signature Certificate.
25. Technical Bid & Financial Bid both will be submitted concurrently duly digitally signed in the website [http:// wbtenders.gov.in](http://wbtenders.gov.in) tender documents may be download from website & submission of technical Bid / Financial Bid as per Tender Schedule.
26. The Bidder, at the bidders own responsibility and risk is encouraged to visit and examine the site of works and it is surroundings and obtain all information that may be necessary for preparing the Bid and entering in to a contract for the work as mentioned in the notice inviting tender, the cost of visiting the site shall be at the Bidders own expense. Traffic management and execution shall be the responsibility of the agency at his / her / their risk and cost.
27. The intending Bidders shall clearly understand that whatever may be the out come of the present invitation of Bides no cost of Bidding shall be reimbursable by the ULB. The Chairman, Santipur Municipality reserves the right to reject any application for purchasing Bid documents and to accept or reject any or all the offered Bid / Bids without assigning any reason whatsoever and is not liable for any cost that might have incurred by the Bidder at any stage of Bidding.
28. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in "Instructions to Bidders" before Bidding.

29. During security, if it is come to the notice to tender inviting authority that the credential or any other papers found incorrect / manufactured / fabricated, that renderer will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice.
30. Before issuance of the work order, the tender inviting authority may be verify the credential & other documents with the original of the lowest Bidder if found necessary. After verification, if it is found that such documents submitted by the lowest Bidder is either manufacture or false, in that case, L.O.A. / work order will not be issued in favour of the bidder under any circumstances.
31. If any discrepancy arises between two similar clauses on different notifications, the clause as stated in later notification will supersede former one in following sequence:
 - i) Special terms & condition
 - ii) Technical Bid
 - iii) Financial Bid (xls. Sheet)
32. Contractor Shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act. 1970 (b) Apprentice Act.1961 and (c) minimum wages Act.1948 of the notification thereof or any other laws relating thereto and the rules made and order issued there under from time to time.
33. Where an individual person holds a digital certificate in his own name duly issued to him / her against the company or the firm of which he / she happens to be a director or partner, such individual person shall, while uploading any tender for and on behalf of such company or firm, invariably upload a copy of register power of attorney showing clear authorization in his favour, by the rest of the directors of such company or the partners of such firm, to upload such tender. The power of attorney shall have to be registered in accordance with the provision of the registration Act.1908.

INSTRUCTION TO TENDERERS/BIDDERS SECTION – A

1. General guidance for e - tendering

Instruction / Guidelines for tenderers for electronic submission of the tenders have been annexed for assisting them to participate in e-tendering.

2. Registration of Tenderer

Any tenderer willing to take part in the process of e-tendering will have to be enrolled and registered with the Government e – procurement system, through logging on to <http://wbtenders.gov.in>. The tenderer is to click on the link for e tendering site as given on the web portal.

3. Digital Signature certificate (DSC)

Each tenderer is required to obtain a class – II or Class-III Digital Signature Certificate (DSC) for submission of tenders, from the service provider of the National Information Centre (NIC) or any other bonafide service provider on payment of requisite amount, Details are available at the Web Site stated in Clause 2 of Guideline to Tenderer, DSC is given as a USB e- Token.

4. The contractor can search and download NIB and tender documents electronically from computer once he logs on to the website mentioned in clause 2 using the digital signature Certificate. This is the only mode of collection of Tender Documents.

5. Submission of Tenders.

General process of submission, Tenders are to be submitted through online to the website stated in CL. 2 in two folders at a time for each work, one in Technical proposal and other is Financial proposal before the prescribed date and time using the digital signature certificate (DSC) the documents are to be uploaded virus scanned copy duly Digitally signed. The documents will get encrypted (transformed into non readable formats).

A. Technical Proposal

The Technical proposal should contain scanned copies of the following further two covers (folders)

A.1. Statutory Cover Containing

- i. Prequalification Application (Sec –B, Form –I)
- ii. Scanned copy of Demand Draft / Bankers Cheque towards cost of tender documents / original documents as prescribed in the NIB, against each serial of work in favour of the Chairman, Santipur, Municipality, payable at Santipur.
- iii. Sanctioned copy of Demand Draft / Bankers Cheque towards earnest money (EMD) as prescribed in the NIB against each of the serial of work in favour of the Chairman, Santipur, Municipality, payable at Santipur. (besides that For e-Filling, EMD (Earnest Money Deposit) Should be sent physically to the office of the Chairman, Santipur, Municipality, Nadia, W.B.)
- iv. Financial Statement (Section –B, Form II)
- v. Affidavits (Ref:- format for general affidavit shown in "Y" part "B")
- vi. Printed Tender Form and NIB (Sl. 10; Part I) with all addenda and corrigendum (**downloaded and upload the same Digitally Signed, quoting rate will only encrypted in the price schedule under Financial Bid. In case quoting any rate in printed tender form the tender will be summarily rejected.**)
- vii. Special Trams, Condition and specification of works.
- viii. Certificate of bank guarantee by any Nationalized Bank (if required).
- ix. Bank Solvency Certificate.

A.2. Non Statutory Cover Containing

- i) Professional Tax (PT) deposited receipt Challan (up to date) PAN Card, IT, IT Return for the current Assessment year, GST Registration Certificate (up to date).

- ii) Registration Certificate under company Act. (if any).
- iii) Registered Deed of partnership Firm / Article of Association and Memorandum.
- iv) Power of Attorney (For partnership Firm / Private Limited Company. If any
- v) Tax Audit Report along with balance sheet and profit and loss A/C for the last three years (year just preceding the current Financial year will be considered as year i)
- vi) Clearance certificate for the current year issued by the Assistant Register of Co-Op(S) (ARCS) bye laws are to be submitted by the Register labour CO-Op(S) Engineers co-opt (S).
- vii) List of machineries possessed by own / arranged through lease deed along with authenticated documents of lease / sub-lease / hire basis etc.
- viii) List of laboratory Instrument.
- ix) List of technical staff along with structure and organization (section B , Form III).
- x) Credential: Scanned copy of original Credential Certificate as stated in NIB (under SI. No.-3).

Note: - Failure of submission of any of the above mentioned documents (as stated in A1 and A20 will render the tender liable to be summarily rejected for both statutory and non statutory cover.

B. Tender Evaluation

- i) Opening and evaluation of Tender:- If any tenderer is exempted from payment of EMD, copy of relevant Government order needs to be furnished (applicable in case of Registered Labour Co- Operative Society).
- ii) Opening of Technical Proposal:- Technical proposal will be opened by the tender inviting authority electronically from the website using his / her Digital Signature Certificate.
- iii) Cover (folder) of statutory documents (vide CL. No.-5.A.-1) should be opened first and if found in order, cover (folder) for non-statutory documents (vide CL No.- 5.A. – 2) will be opened. If there is any deficiency in the statutory documents' the tender will be summarily be rejected.
- iv) Decrypted (transformed in to readable formats) documents of the non-statutory cover will be downloaded and handed over to the tender evolution committee. Scrutiny of technical proposal and recommendation thereafter and processing of comparative statement for acceptance etc. will be made by the Chairman, santipur, Municipality. Comparative statement may be forwarded to appropriate authority depending on the value of the work as applicable as per existing norms and guidelines undr BEUP.
- v) Uploding and summary list of technically qualified tenderers.
- vi) Pursuant to scrutiny and dicision of the screening committee the summary list of eligiable tenderer and which their proposal will be considered and uploaded in the web portals.
- vii) While evolution, the committee may summon the tenderers and seek clarification / information or additional documents or original hard copy of any of the documents already submitted and if these are not produced within the stipulated time frame, their proposals will be liable for rejection.

C. Finincial Proposal

- i. The financial proposal should contain the following documents in ove cover (folder) i.e. bill quantities (B.O.Q.) the contractor is to quote the rate online through computer in the space marked for quoting rate in the B.O.Q.
- ii. Only downloaded copess of the above documents are to be uploaded virus scanned and digitally signed by the contractor.

6. Financial capacity of a tenderer will be judged on the basis of working capital and available bid capacity as mentioned in the N.I.T. to be derived from the information furnished in **FROM –I and II** (Section – B) i.e. application (for pre-qualification) and Financial statement. If an applicant feels that his / their working capital beyond own resource may be insufficient, he / they may include with the application a letter of guarantee issued by a first class bank to supplement the applicant. **This letter of guarantee should be addressed to the tender inviting / Accepting Authority and should guarantee duly specifying the name of the project that in case of contract is awarded to the tenderer; The tenderer will be provided with a revolving line of credit.** Such revolving line of credit should be maintained until the works are taken over by the Authority. **The audited Balance sheet for the last three years**, net worth bid capacity etc. are to be submitted which much demonstrate the soundness of Tenderers Financial position, showing long term probability including an estimated Financial projection of the next two years.

7. Penalty for suppression / distortion of facts.

Submission of false documents by tenderer is strictly prohibited and in case of such act the tenderer the same may be referred to the appropriate authority for prosecution as per relevant IT Act with forfeiture of earnest money forthwith.

8. REJECTION OF BID
